# **THE 2017-2018 BUDGET**

**RESOLVED**: That the Board of Education of the Berlin Central School District is hereby authorized to expend a sum, not to exceed **\$20,127,758**, in the 2017-2018 school year, and to levy the necessary tax therefore on taxable property of the district for the tax year beginning July 1, 2017.

## **PROPOSITION NO. 1**

**RESOLVED** that, pursuant to Section 1804 (12) of the Education Law, the Board will submit the following question to the voters at the May 16, 2017 annual school district budget vote/Board election:

Shall the District allow a Berlin High School student to serve as a nonvoting member of the Board of Education?

## **PROPOSITION NO. 2**

Shall the following resolution be adopted, to wit:

**RESOLVED**: That the Board of Education of the Berlin Central School District, Rensselaer County, New York, is hereby authorized to purchase in fiscal year 2017-2018 one (1) 66 passenger school bus and expend a gross sum not to exceed \$120,000. Which said total sum of \$120,000, or so much thereof as may be necessary, may be raised by issue of obligations of the district therefore in accordance with the education law and local finance law.

#### **PROPOSITION NO. 3**

Shall the following resolution be adopted, to wit:

**RESOLVED**: That the Board of Education of the Berlin Central School District, Rensselaer County, New York, is hereby authorized to repair, replace, upgrade, reconstruct, and install and make improvements to the gymnasium area, including the stage, at the Berlin Elementary School building, including all original furnishings, equipment, machinery, apparatus, appurtenances, hardware and software and incidental improvements and expenses in connection therewith, and is further authorized to expend therefore an amount not to exceed \$100,000, to be raised by the levy of a tax upon the taxable property of said School District and collected in annual installments as provided by Section 416 of the Education Law; and in anticipation of such tax, obligations of said School District shall be issued.
